7.1.2 (6) POLICY FOR ENERGY UTILIZATION AND ENVIRONMENT

- ❖ To install LED bulbs in the campus to save energy.
- ❖ To develop systematic waste management mechanism.
- ❖ To develop rain water harvesting unit.
- ❖ To undertake tree plantation drive.
- ❖ To take additional measures to continuously improve our energy consumption
- ❖ To ensure the availability of necessary resources to achieve our objectives.
